SW is moving to an investment principle strategy and are organising themselves to be more ruthless. As they are still going through the strategy, all NGB's have had a cut this year. BW has had a fall in number of memberships, currently 1600 down from 2100 members due to membership system transition	
	CD – Do we know what BW finance will look at post SW strategy?	KA – SW still don't know what our funding will look like post reorganisation. We have been told to expect cuts year on year, for the next few years (5-10% scenario plan).

		made, but the funding cuts apply to the whole of Badminton Wales's activities. A new CEO's role was created, and KA was appointed.

		DS – in Conwy, each club needs an administrator for player registrations. The Club then sends the list and the payment to the county who pays BW.
