- 1. All applicants must have a minimum **four-year** residency within the Mid Glamorgan boundary and currently be a resident within the Mid Glamorgan boundary.
- 2. All applicants must be under the age of 19
- 3. All applicants must have a British Passport.
- 4. All applicants must at a minimum level demonstrate the ability to represent an official Badminton Wales National team.
- 5. The maximum individual grant amount is 100GBP.
