Please note that MID GLAMORGAN JUNIOR BADMINTON DEVELOPMENT FUND provides the opportunity for local Mid Glamorgan junior players to apply for funding to support with training and competition costs. The funding award criteria: -

- 1. All applicants must have a minimum **four-year** residency within the Mid Glamorgan boundary and currently be a resident within the Mid Glamorgan boundary.
- 2. All applicants must be under the age of 19
- 3. All applicants must have a British Passport.
- 4. All applicants must at a minimum level demonstrate the ability to represent an official Badminton Wales National team.
- 5. The maximum individual grant amount is 100GBP.
